

The Evidential Argument for Passing Romanch's Law

Times Square was once Longacre Square. Its blocks were lined with blacksmiths and stables where horses were shod, and it was the home of the Vanderbilt's American Horse Exchange. But the city grew too dense, too loud, and too mechanized, and the horses were pushed out. That was more than a century ago. The city today is far more crowded, far noisier, and far more chaotic than anything Longacre Square ever saw. Still, the horse carriage industry attempts to operate on the busiest pathways in Central Park, the third most visited tourist attraction in the world.

Today we're reckoning not only with an industry many say needs to be more tightly regulated, if not outlawed altogether, but the death of a young man, Romanch Mahajan, who came to New York with his family for what was supposed to be the trip of a lifetime, and who fairly assumed, along with his family, that when they took a city-regulated tourist ride, it would be safe. This was an avoidable tragedy; one no family should ever have to face. On June 17, 2026, Romanch Mahajan was killed after a carriage horse spooked near Cherry Hill, broke free, and bolted down West Drive, slamming into another carriage and flipping it near Tavern on the Green. It was the first carriage-related human death in the record, and the eighth horse-related incident in or around the park in the past thirteen months.

The tragedy should not have been a surprise. Across the incidents we have on record going back to 1982, a runaway carriage horse has hurt a bystander just under half the time. Just days earlier, a 16-year-old horse named Deniz collapsed and died on West Drive with two passengers still in the cab. Last September, a horse named Bambi bolted through the park, throwing her driver to the ground and forcing passengers to jump from the moving carriage. In 2022, a horse named Ryder collapsed emaciated in traffic and died months later.

The death of anyone, especially a young person, should be enough to demand change. But any decision to change an industry that has operated in this city for generations needs to be made with care and with evidence. So we took a step back and looked at the sober statistics around this issue. We reviewed public records, including Department of Health and Mental Hygiene data, for every documented report of a carriage-horse incident in or around Central Park going back to 1982.

What we found was evidence of 96 serious carriage horse incidents, including human injuries, and 40 horse deaths. Between 1982 and 2026, the annual incident rate has more than quadrupled. In just under half those cases, a horse died. And when a horse escapes its carriage, our data show a person is hurt half the time. The trend is only getting worse with time. Over the last thirteen months alone, we counted eight incidents, more than double the pace the industry has averaged since 2019. We collaborated with a Professor from Columbia University on a forecast model based on this dataset. If the pattern holds, our forecast shows we could see sixteen to thirty more carriage incidents by 2030, almost certainly with human injuries, and upwards of eleven more horse deaths.

The full incident roll is listed in the appendix to this piece. Assembling even that much was harder than it should be: no single, reliable public record of these incidents and deaths exists. The count had to be stitched together from animal-advocacy compilations, public reporting, and limited records from the Department of Health and Mental Hygiene.

Horses are not city animals. Placed in an environment filled with countless pedestrians, sirens, e-bikes, crowds, delivery vehicles, and construction noise, they startle and pose a serious risk themselves as well as anyone around them.

New Yorkers see this too, and they have been reporting it. A recent public opinion poll by Zenith Research found that 68% of respondents supported ending horse-drawn carriages in New York City. We also analyzed every 311 complaint filed under the City's animal-abuse category that names a horse since 2020. Of 175 such complaints citywide, 117 of them, 66.9%, were filed within about two streets and one avenue of Central Park or at the two licensed carriage stables in Hell's Kitchen. Callers most often reported neglect or torture, though these labels reflect what concerned New Yorkers reported rather than findings adjudicated by any agency. The majority of these complaints were closed with no enforcement action recorded, typically logged as no evidence observed or no action necessary. Enforcement action was recorded in just 18.3% of these complaints, well below the 28% rate across all animal-abuse complaints citywide. Over the same years New Yorkers filed another 92 complaints against the carriage trade itself with the City's consumer-protection agency.

It's clear the status-quo is unacceptable. That's why I joined my colleagues in cosponsoring City Council Intro. 943, called Romanch's Law, which would wind down the horse-drawn carriage industry.

But any serious case for winding this industry down has to reckon with the hundreds of workers who will be at risk of losing their livelihood. The City has an obligation to collaborate with them on finding a professional landing. Intro. 943 directs the Department of Consumer and Worker Protection (DCWP) to build a workforce transition program. It is crucial the City Council and DCWP ensure this program is funded and staffed before drivers lose their routes.

Intro. 943 also prohibits selling or transferring any horse for slaughter or into another city's carriage business. Last September, two dozen equine rescues and sanctuaries offered to place every horse this industry retires. The City must work with that coalition to ensure a smooth and safe transition.

The horse-drawn carriage industry has operated in New York City for generations; yet the record makes clear it cannot continue to operate as it has. Ninety-six documented incidents, forty horse deaths, and now the city's first carriage-related human death show a risk that is only growing. Intro. 943 offers a responsible path forward: it winds the industry down on a fixed timeline, protects the horses from slaughter or resale into another city's carriage trade, and funds a real transition for the drivers who depend on this work.

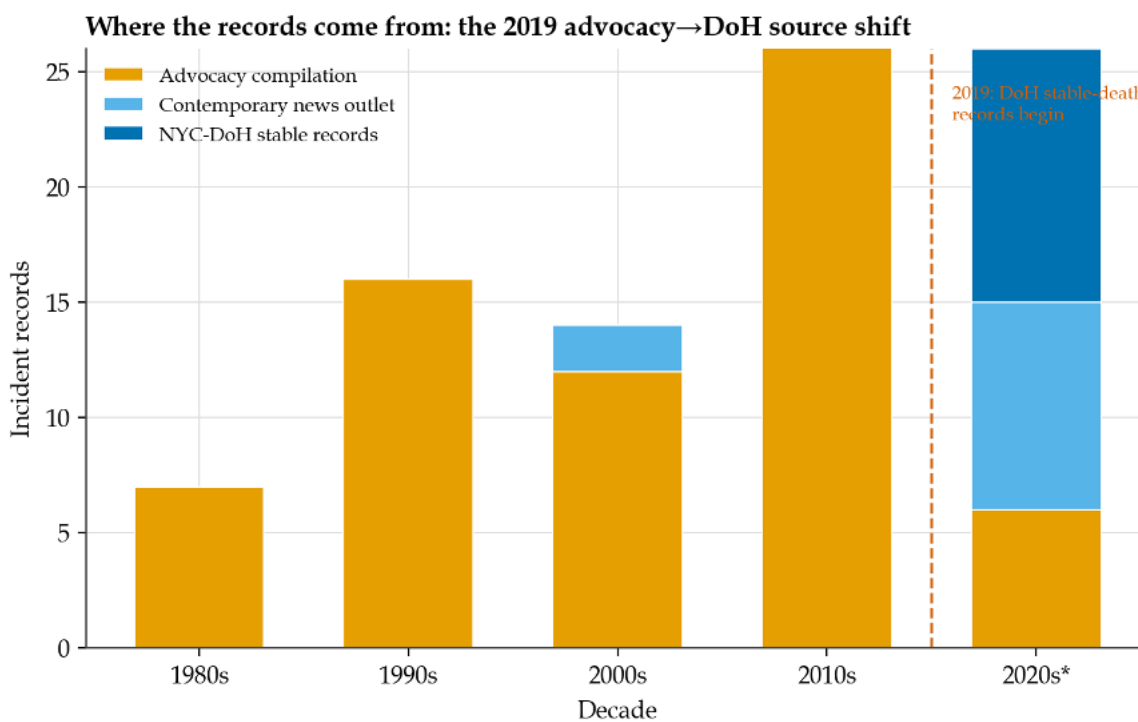
The City must act now.

Appendix

Part 1: What the Data Shows

We built this analysis on 96 curated incident records running from August 4, 1982 to June 17, 2026, merged from three kinds of sources: a compilation kept by the Coalition to Ban Horse-Drawn Carriages (banhdc.org and its running blog), contemporary news coverage, and the NYC Department of Health and Mental Hygiene's own licensing registry. No city agency has released an official public database of these incidents, so the count below is a lower bound of the full incident history.

The types of record shift significantly in 2019: through 2018, nearly every incident record comes from the advocacy compilation, some of which can be corroborated against public reporting; from 2019 on, the Department's own stable-death records and news outlets confirm most of the records. Some of the difference between the 2010s and the 2020s reflects an actual increase in incidents; some of it is simply that more of the record is now visible than it used to be. Within the incidents we do have, some fields are too sparse to build further analysis on: most notably, whether passengers were aboard a given carriage is unrecorded in 81 of the 96 incidents, which is why nothing here attempts a per-ride risk rate.

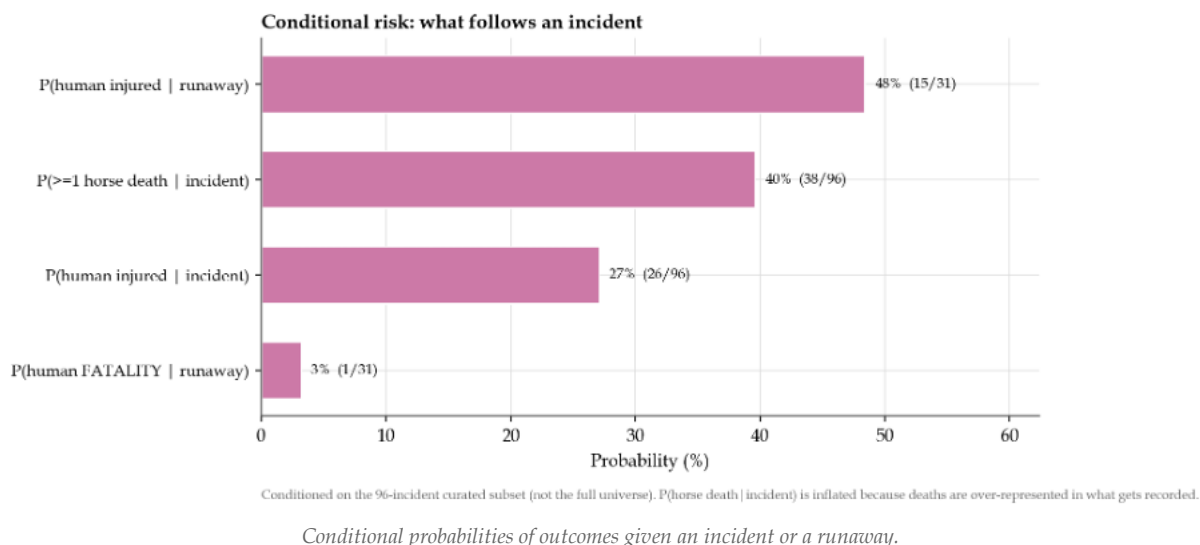


*2020s through June 17, 2026. No mandatory accident reporting exists; counts are a merged advocacy+news+DoH compilation, not a registry.

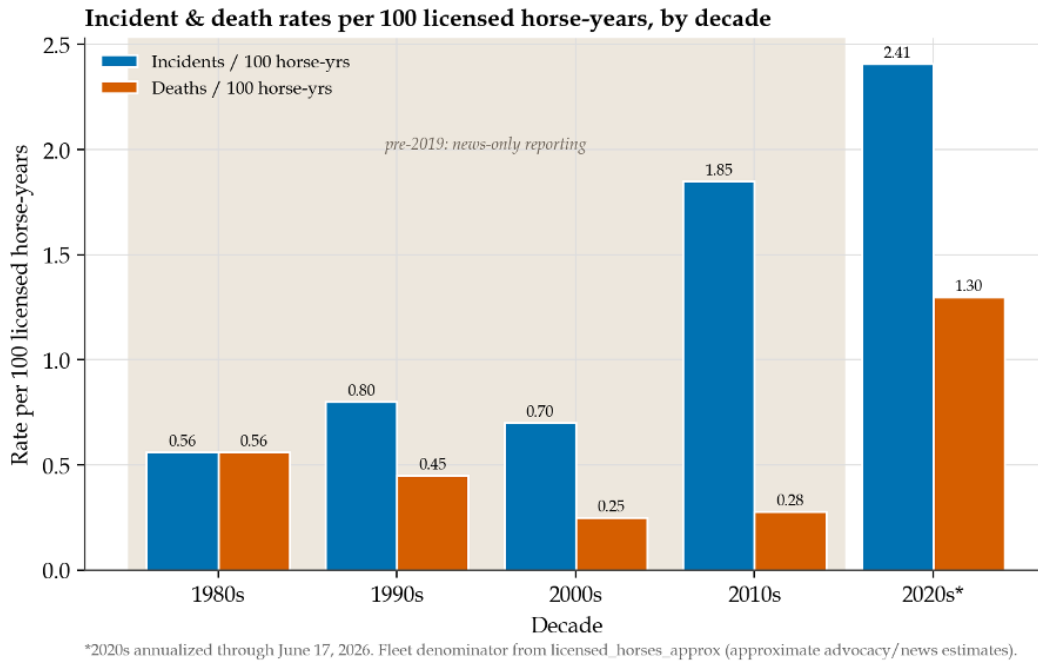
*Records by source group and decade. *2020s through June 17, 2026.*

The clearest and most consequential number in this dataset is injury to people. Across the 31 recorded runaways (our term for incidents where a horse broke loose and bolted, as distinct from, say, a stable collapse or an act of cruelty toward a horse), just under half, 15, have ended with a bystander, driver, or passenger injured. One has now ended in a death. On June 17, 2026, an 18-year-old tourist was killed when a carriage horse spooked near Cherry Hill, broke free

down West Drive, and slammed into another carriage near Tavern on the Green. It is the first fatality in the record, and it happened inside a pattern of injury that was already close to a coin flip. If you widen the lens from runaways to every incident in the record, a person was hurt in just over a quarter of them. At least one horse died in about two in five incidents (39.6%, 38 of 96), though that share is inflated by the simple fact that a death is more likely to get recorded at all than a close call that ended without harm.

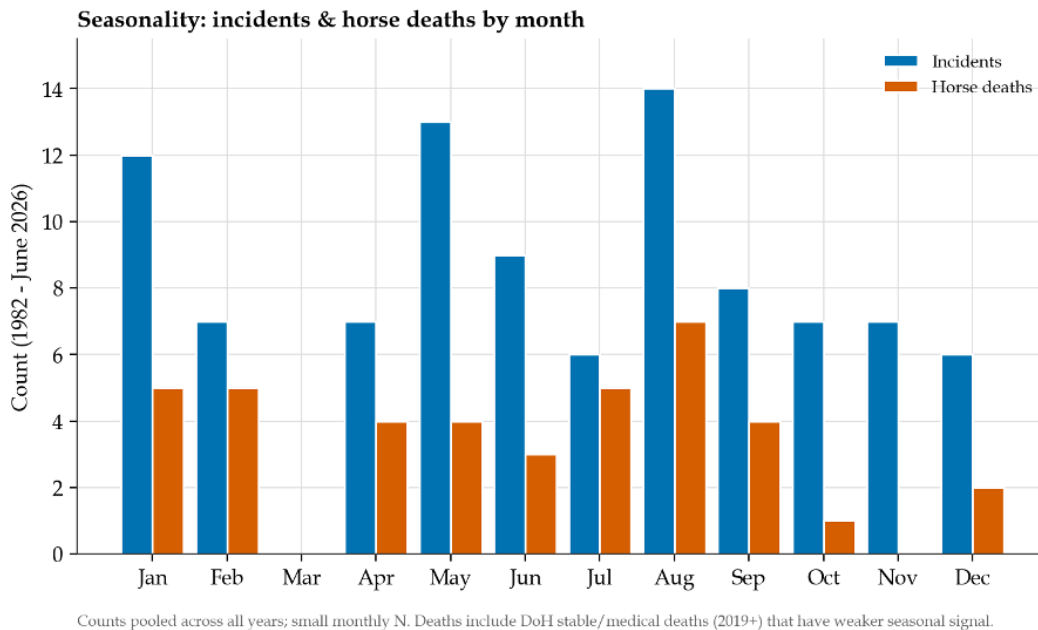


To understand the significance of this data, we normalized for the size of the fleet. For this analysis, a horse-year is one horse licensed to work for one year, the same unit epidemiologists use as a person-year; we use it as the denominator for a rate so that a decade with more horses on the street isn't unfairly compared to one with fewer. Incidents per 100 licensed horse-years have climbed steadily, from roughly 0.7 across the 1980s through the 2000s to 1.85 in the 2010s and 2.41 in the 2020s so far. The death rate looks, at first glance, like it triples into the 2020s, reaching 1.30 per 100 horse-years, but most of that jump is the Department's stable-death records becoming visible for the first time after 2019 rather than horses actually dying at a higher clip.

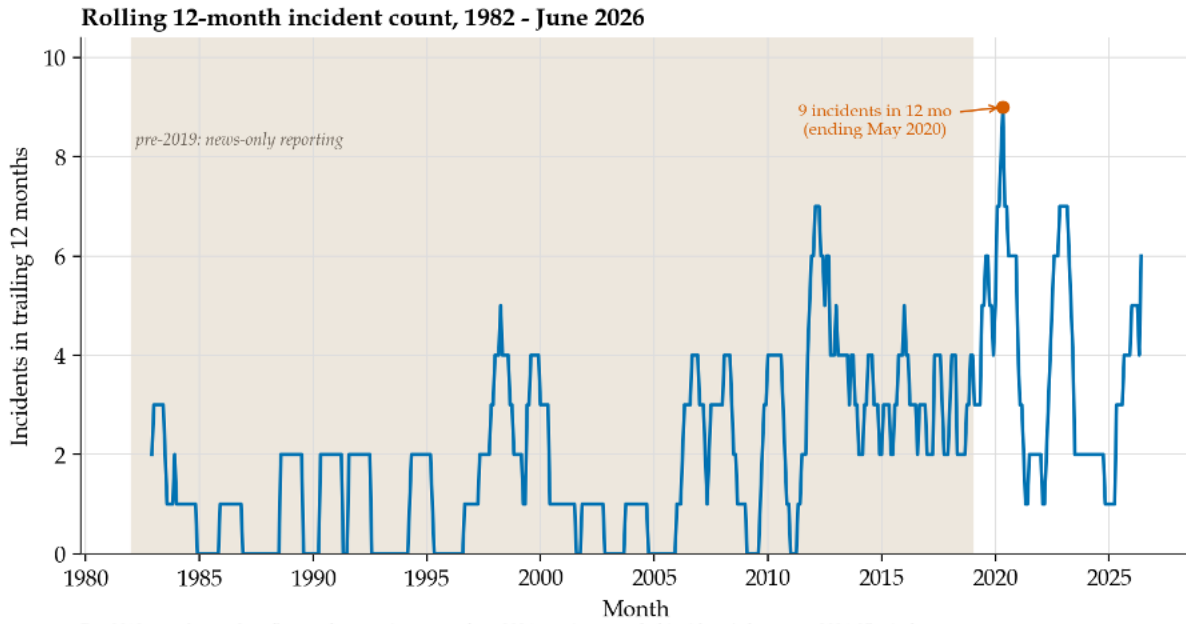


Incident and death rates per 100 licensed horse-years, by decade.

The street incidents themselves cluster by season. Incidents peak in August (14 of 96) with secondary clusters in May (13) and January (12); horse deaths peak in August too (7) and July (5), and the summer months of June through August alone account for 15 of the 40 deaths, of which 5 are explicitly heat-triggered.



Incidents and horse deaths by month, pooled 1982 – June 2026.



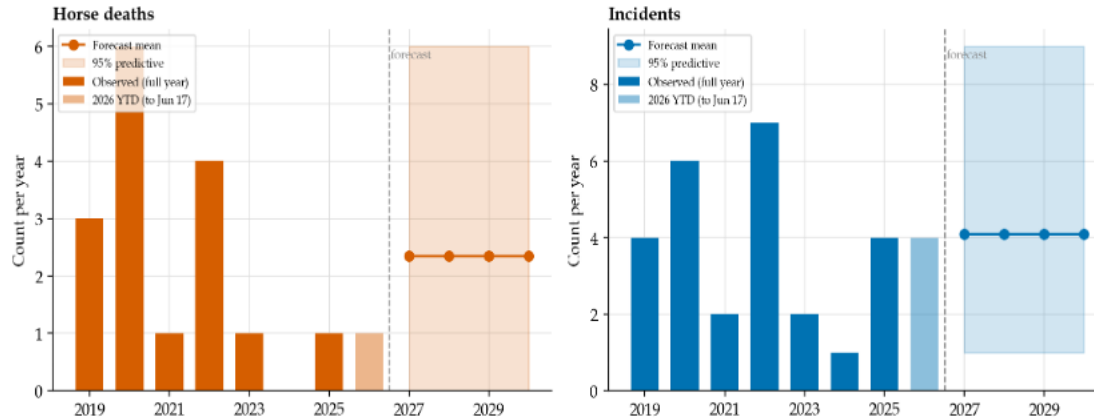
Incidents in the trailing 12 months, 1982 – June 2026.

The forecast to 2030 if nothing changes

We fit a status-quo forecast on the one window in this record we trust to be reasonably complete -- the 30 incidents and 17 horse deaths recorded since 2019, a 7.5-year span in which the Department’s own records and steady news coverage were more reliable. Holding the industry at its current size, that window suggests we could see roughly 4 incidents and 2 to 3 horse deaths a year going forward. Run out across the rest of the decade, that is about 22 horse deaths in the 2020s in total (95% interval, 16 to 30) and roughly 40 incidents.

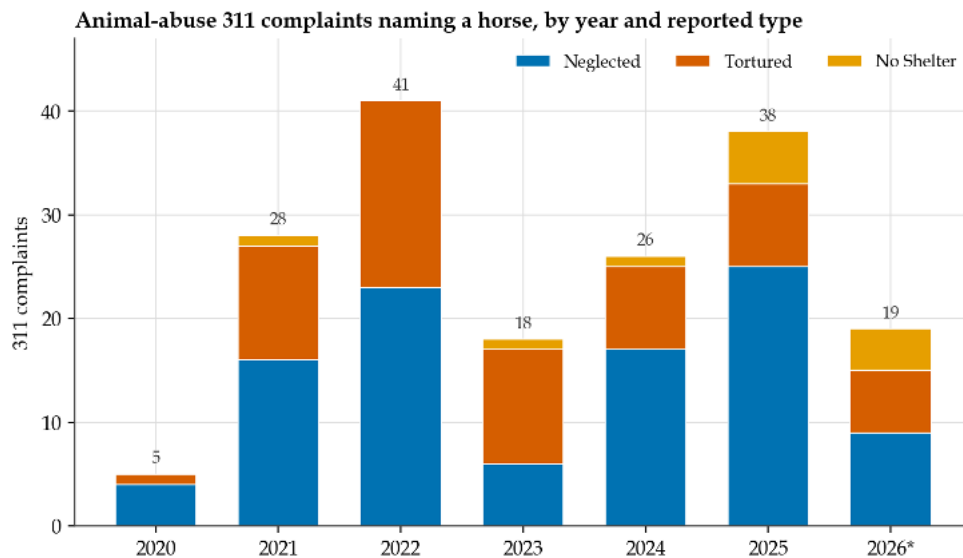
Status-quo forecast fit on the post-2019 reporting window; observed counts in solid bars, forecast means and 95% posterior-predictive bands to 2030.

Deaths show no upward trend within this smaller window. But in the case of street incidents, the past 13 months ran at nearly double the post-2019 average pace, 7.4 versus 4.0 a year. If that faster pace holds rather than reverting to the longer window's average, the 2027-2030 period would see closer to 30 incidents rather than the roughly 16 the longer-run rate alone would predict.

This is deliberately a status-quo model: it assumes no ban or wind-down and a stable fleet of roughly 190 horses. We modeled counts with a constant-rate Bayesian Poisson process, the standard statistical model for rare, roughly independent events like these, starting from a Jeffreys prior (a mild, standard starting assumption that lets the post-2019 data do most of the work) and reporting a Negative-Binomial posterior-predictive interval (a range built to cover both our uncertainty about the true underlying rate and ordinary year-to-year randomness).

Part 2: What New Yorkers Reported to 311 and DCWP

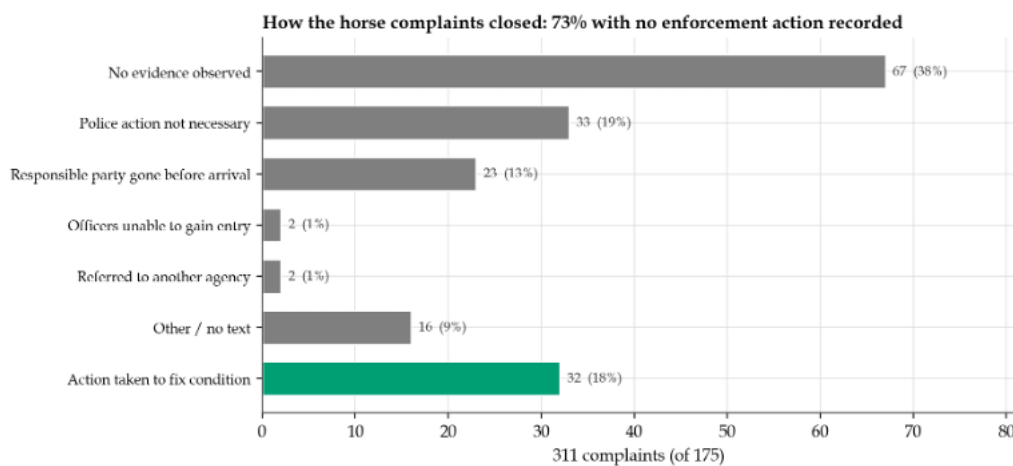
New Yorkers have filed 175 animal-abuse complaints to 311 since 2020 that name a horse. 117 of them, 66.9%, were filed inside the industry's own footprint: within about two streets and one avenue of Central Park, or at the two licensed stables in Hell's Kitchen. Volume climbed from a handful in 2020 to more than twenty complaints in most years since. Callers most often reported neglect (100 of 175) or torture (63), with a smaller share citing a lack of shelter (12); within the carriage footprint the split is 63 neglect, 49 torture, 5 lack of shelter. These labels describe what a caller reported to the city, not a finding adjudicated by any agency.

*Animal-abuse 311 complaints naming a horse, by year and reported type. *2026 partial, through June 22.*

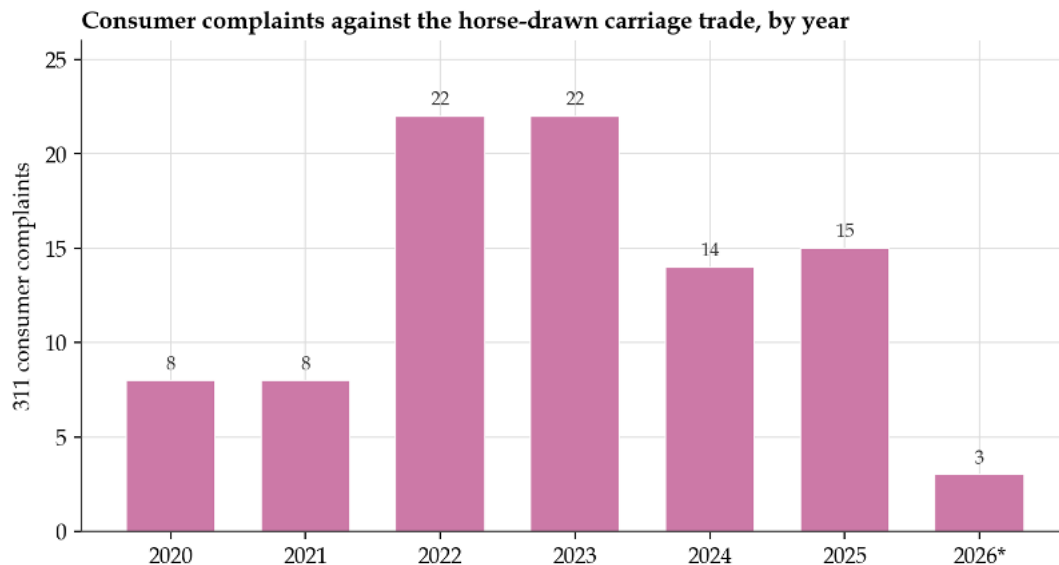
In 127 of the 175 cases, 72.6%, the file shows no enforcement action at all: most often logged as “no evidence of the violation observed” (67) or “police action not necessary” (33), with a further 23 closed because whoever was responsible had left before officers arrived. Action to actually fix the condition was recorded in just 32 cases, 18.3%, well below the 28% rate recorded across all 54,562 animal-abuse complaints citywide since 2020. Importantly, a complaint closed with no recorded action is not proof that nothing was wrong; it reflects only what an officer could observe or document on arrival.

Separately from those abuse reports, New Yorkers have also filed 92 complaints against the carriage trade itself with the city’s consumer-protection agency since 2020, logged under the descriptors “Horse-Drawn Cab” and “Horse Drawn Carriage.” Nearly all of them, 89 of 92, are in Manhattan, and the single most-named address is the Clinton Park stable on West 52nd Street.

Part 3: Incident Dataset

There is no single authoritative public record of carriage-horse incidents or deaths in New York City. None has been released publicly, and we were unable to find one central, reliable source that documents them with any consistent detail. This dataset is therefore stitched together from three kinds of records. The first is the advocacy compilations maintained by the Coalition to Ban Horse-Drawn Carriages (banhdc.org and the running “NYC Carriage Horse Accidents” post at carriagehorsesnyc.blogspot.com), which supply most of the pre-2019 rows but are themselves self-described as incomplete. The second is contemporary news coverage. The third is the New York City Department of Health and Mental Hygiene’s own licensing registry, run March 11, 2026, which lists every licensed carriage horse back to 1990 and flags those reported deceased.

Merging the three produces a fuller count (96 incidents and 40 horse deaths) than either advocacy source or the Department’s registry provides on its own. It remains a floor rather than a complete tally: an unknown number of incidents and deaths almost certainly went unrecorded altogether, names and ages are uneven, several horses survive in the record only as “Unnamed,” and descriptions range from a Cornell necropsy (Deniz, Lady) to a one-line news mention. The table below is the complete underlying dataset, sorted by date. Every incident referenced elsewhere in this piece, including each of the 40 deaths by name and cause, can be found in it.
